I have been given the opportunity and have been encouraged to seek independent legal advice prior to signing this Waiver and Release Agreement. I understand that this Waive and Release Agreement is binding on me, my spouse, my heirs, my executors, administrators, personal representatives, Participant and assigns.

By signing this release I will be forever prevented from suing or otherwise claiming against the Releasee for any property loss or personal injury that Releasor or Participant may sustain while participating in or preparing for the above noted activity.

I understand that Participant will not be permitted to participate in the above noted activity unless I signed this Waiver and Release Agreement. I acknowledge that Participant does not have any physical or mental limitations, medical ailments, that would limit or prevent Participant from participating in the above mentioned activity, and, if required, will obtain a medical examination & clearance.

This release contains the entire agreement between the parties to this release and the terms of this release are contractual and not a mere recital. This Waiver and Release Agreement will be construed in accordance with and governed by the laws of the State of New Jersey, and it is acknowledged by the Releasor to be as broad and inclusive as permitted by the laws of this jurisdiction.

I HAVE READ AND UNDERSTAND THIS AGREEMENT, AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS WHICH I OR MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS, PARTICIPANT, AND ASSIGNS MAY HAVE AGAINST THE RELEASEE(S).
